Amber,

Chloride analysis was run on the samples obtained from our initial site visit. Please see the April 13, 2016 data table. Results at worst-case scenario location (S-1) indicated total chlorides at 48 and 80 mg/kg respectively, well below the 250 mg/kg delineation threshold required by the NMOCD. Therefore, chlorides were not a component of the rest of the sampling parameters.

Legacy Reserves absolutely will comply with the NMSLO Surface Restoration Guidelines, which I have attached. We will forward a re-vegetation plan in accordance with the attached guidelines to the NM State Land Office for your review under a separate cover.

As our client would like to proceed as soon as possible with the remediation at this location, we respectfully request that our proposed work plan be reviewed in accordance with the NMOCD cleanup guidelines. Thank you.
