Audra,

I have attached a final C-141 for the Dorstate. Please review it with Jerry and let me know if you would like to make any changes. My intention at this point is to get the RP closed with NMOCD since the 500bbl release was contained and the fluid was recovered. The staining on location should be considered "routine housekeeping" since it did not meet the minimum reporting requirement of 5bbls. Keep in mind that OCD can require action on any release that they deem "poses a reasonable probability to endanger public health and/or results in substantial damage to property or the environment."

Also for future reference when you are working on C-141's. With releases such as this where all of the fluid is contained and recovered, you can check both the Initial and Final boxes. This satisfies your reporting requirement but effectively closes the RP immediately. Also the portion of the C-141 that asks about "immediate notification" is refereeing to notification of OCD. You are required to notify OCD immediately if you have a release of 25bbls or more. You have 15 days to notify them of a release greater than 5bbls, but less than 25bbls.
