Bob, et al - A couple of questions.

1. Please clarify the pre-spill condition of the tank-berm area. Was there a liner of any sort?
2. On page 2, the Section "VI. Action Plan" states that soils with greater than 1000 mg/KG TPH will be excavated. Which sample points were those?
3. Regardless of the extent of this particular clean-up, BLM will not relieve Holly of final responsibility for this contamination until the point in the distant future when the site is decommissioned and the R/W is relinquished.

Also, Figure 2 - Site Plan. It would be more helpful to have a hand-drawn map showing circular outlines of tanks, with the spill area drawn in. Exact scale would not be needed, if relevant field measurements are shown on the drawing.

I'm not sure who your Holly contact is. But please pass onto them that this facility is authorized under a BLM R/W, Serial No NM-105028. That number is required to be posted on the site. That will help remind them that spills at this facility are not lease operations, and should be reported to BLM's Realty section.
