OCD notes your remediation proposal for the above referenced release, is an alternative proposal to the one approved by OCD on 11/29/16. This alternative proposal was discussed in a meeting at the OCD District 2 office on 3/14/17. Attendees were you, Casey Summers w/OXY and me. At this time, OCD approves your proposed alternative method. Target goal for cleaned soils is 250 mg/kg, with the understanding that this goal may not be achievable due to natural chloride levels in water used in the process, however, it is OCD's understanding that water used will be from a "fresh water" source and should be as close to potable as practicable. Cessation of remedial operations and reuse of remediated material will require OCD approval after review of analytical data. This is a Federal site and will require like approval from BLM on all aspects of the proposal and ultimate closure. OCD may require the original proposal be initiated if a determination is made that this alternative is not effective or practicable. Please advise once remedial activities have been scheduled.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
