Good morning,

WPX had a spill yesterday, 1/30/17, at the McKittrick 29 Federal com 22; API 30-015-29351; E-29-22S-26E. The spill was caused by equipment failure - hole in the oil tank. Approximately 32 bbls of oil leaked out of the tank into a dirt SPCC containment. Less than 0.5 bbl saturated the berm and stained a small area outside the berm. The spill did not migrate off location.

The C-141 report will be submitted in the next 15 days.
