Good morning,

WPX had a spill yesterday, 4-20-17 at 1:20 pm at the RDU 11 pad. API # 30-015-24307, qtr/qtr O-S22-T26S-R30E. The spill was caused by human error; the equipment setup was changed and the calibration guys were given a wrong information. They closed a valve that should've been open which resulted in over-pressuring an above ground poly line. Approximately 50 bbls of oil and water was spilled off location north and west of the location. All free liquids were recovered with a vac truck and the recovered volume will be included in the C-141 report.

WPX would like to ask for BLM's permission to excavate the top 1-2' of the impacted area to prevent from vertical migration. The area will be sampled after the excavation activities are completed. There are no arch sites at the spill location.
