On May 1, 2017, you sent an email to OCD (I was not copied on that email) requesting an extension for 2RF-105. At some point in May 2017, that email was forwarded to me. On May 31, 2017, I responded to your request for an extension. The extension request was denied. After researching further, there was some data omitted from that email, so I am sending you OCD records to date, for 2RF-105.

- Usage of the facility was reported for November and December 2015.
- No usage was reported for January, February, March, April and May 2016.
- On June 7, 2016 a six-month extension was approved.

- No usage was reported for June, July, August, September, 2016
- Usage for October 2016 was reported as IN (other) 84,361 bbls fresh, with 109,361 bbls discharged.
- From November 2016 through June 2017, no usage has been reported.
- Out of the facility's 20 months in service, usage has only been reported for 3 months, and, the total volume received vs total volume discharged do not correlate.

At this time, the OCD District 2 office requests closure of this facility per [19.15.34 NMAC].

You may choose to set the matter for hearing, or discuss any other available options with the OCD Environmental Bureau Chief, Jim Griswold.
