Your request for closure of the above referenced release is denied. Deferral requests for this location will not be entertained. Please remit an alternative work plan.

Delineations need to be complete and involve lab samples starting in 1 ft. increments testing for benzene and total BTEX (Method 8260 or 8021), TPH (Method 8015 extended range GRO DRO and MRO) and chlorides (Method 300.0 from surface down till constituents show clean would be what we require (plus an additional 10' from there in 5' increments)(Aaron you may recall we had previously discussed the issues we have with this type of format in data that is in this work plan when we discussed the work plan from the project that was submitted to Olivia Yu in OCD District 1, 1RP-3061 CMU #99).
