On behalf of Southwest Royalties Inc. (Noble Permian LLC), I am respectfully asking for an 30 day extension for Case # 2RP-4322 (POGO 36 State #1 Battery). The deadline for Case # 2RP-4322 site characteristic report is August 31, 2017. Noble Permian LLC is currently transitioning from Southwest Royalties Inc., thus having to get new Master Service Agreements with its vendors. Republic Backhoe Services LLC has filed all the necessary documents with Noble Permian LLC, but as you know remnants of Hurricane Harvey have caused flooding in Houston, TX. Noble Permian LLC has closed its corporate offices in Houston TX until Wednesday August 30, 2017.
