I thought we had closed these out already. Looking back at the file, it looks like Heather Patterson had some question as to what was blended, what was hauled and depths, and then some discrepancies with a map. In your last email, you sent a corrected map and then stated "I am working to develop a more formal work plan to address the questions that you have regarding what was blended as well as depths.". Looks like that is where it ended. SESI did submit Final C-141s for both releases in their report, so based on your email below, I will go ahead and approve both incidents for closure. The approved Final C-141s should be available for view on OCD Online by tomorrow. I will process them now, but I think the system may have to "batch" overnight.

Mike,

Have you had a chance to look at these updates? I spoke with the foreman over this project and he stated that they ended up not blending any soil, but instead all of the stockpiled soil was removed, initially the plan was to remove some soils and blend others, but after speaking with the foreman, all of the impacted areas within Bob's initial sample area were removed to a depth of 2'. The land owner was directly involved as he indicated where the top soil would come from and we excavated that to replace the soil we had removed.

I have attached the revised map addressing the lack of an AH-1 on the map, this was a typo by SESI that I missed. I am working to develop a more formal work plan to address the questions that you have regarding what was blended as well as depths.

Brett,

It looks like your email to Heather dated October 28, 2016 (last email in this chain) included a closure report and the Final C-141s. I wasn't copied on that email, so I don't have those documents. Please resend to me. That document initiated her questions/request, and you responded to that request on 12/2/16. That is where this stops on our end. Some questions I have in regard to that response is: The first attachment in your response (12/2/16) is titled Sample Points Map and Test Results. I have two issues with that document. The page that shows the analytical tables ("Analysis Results: Lab and Field Tests") references a sample point labeled "AH-1". It shows AH-1 @ 1' returning a value of 1,743,164 (assume mg/kg). I would expect that is a misprint? Also, AH-1 is not shown on the map. There is a sample point labeled SP-1 and it is in bold black type, similar to AH-2. I believe this is also likely a misprint. If these are misprints, just include a statement when you send the closure report and Final C-141s stating such.

Heather had also asked for clarification as to excavation depth and what soils were hauled to disposal vs what was blended. My recollection of this project is that hauling soil to disposal is where things went south with the surface owner. I don't think anything was hauled to disposal, but we need to know that from you guys. Also, I am inclined to request obtaining something from the surface owner stating he is OK with, or signs off on, what was done out there.

Let me know what you think, or if we need to discuss further.
