Good morning, I'm writing to request closure of a gas release in southeast Eddy county. The minor gas leak occurred earlier this year, and unfortunately was right on top of two high-pressure DCP lines. While coordinating with DCP, we were able to excavate to a depth of 4', along the ROW. Closure samples have been collected and show the site is well below the prescribed action levels. As such we're requesting approval to backfill the excavation and close out this spill file.
