**Subject:** WPX Brushy Draw Booster Station - spill notification

Good afternoon,

Yesterday, 11/13/16, WPX had a produced water spill at the Brushy Booster Station location. The cause of this spill is equipment failure; a cross arm on an electric failed which cut off power supply to the water transfer pump. Additionally, the ESC float got stuck and didn't trigger the high water alarm notification and didn't shut in the system. Approximately 200 bbls of produced water and stormwater were recovered from the secondary containment (estimated at least 80 bbls of stormwater).

The Brushy Booster Station is located south of the Fed UCBHWW 1, API # 30- 015-24034, qtr/qtr M, S25, T26S, R29E.

The C-141 report will be submitted within 15 days from the incident.
