- 1.) I am sending you your signed C-141's for the releases you informed us of at Yates State Battery (tracking number 2RP-4085) and Hastie Federal Battery (tracking number 2RP-4084) **along with our required Conditions of Approval attachment.**
- 2.) I am also requesting that you please include me on all your OCD District 2 correspondence regarding spills from here on out, but **also please note that if the spill is on State land or Federal land you need to include the ladies I added to the cced section of my email above.** Amber Groves is who you need to inform for all State owned land releases and Shelly Tucker is who you need to inform for most of the Federal owned land releases. If you have any further questions for them please follow up with them.
- 3.) Also please make sure to include latitude and longitude (decimal degree preferably) coordinates on every C-141 spill report turned in.
