OCD approves this remediation proposal with the following conditions/additions:

- Target Chloride clean up levels are 600ppm or better regardless of site ranking score. Therefore OCD will require that around the area of SP1 the excavation is to go all the way thru the 3' interval and at area around SP2 excavation is to go all the way thru the 4' interval.
- Please notify OCD regarding the schedule of remedial activities.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
