Clif,

Thank you for your response. Your efforts regarding the remediation of this release will need to be followed by a through sampling effort which would involve lab samples verifying clean sidewalls in all cardinal directions of the spill plume. As well I had given you a COA handout that states a full vertical delineation will be required. Vertical delineation needs to occur in the area where the spill has pooled the most. Please refer to the COAs on recommendations/expectations of how to complete said vertical delineation and sampling requirements.

Crystal,

After evaluating the Ranking Criteria, our Total Ranking Score is in the 0-9 column. What we have done: As soon as we found the spill, which was within minutes of when it started, we got RT Trucking to pick up all of the oil that they could. Right after that we completely covered all contaminated soil with Gator, an oil neutralizing compound, and tilled it all in. Two nights later it rained and we repeated this process two more times

and then covered it again with Gator.

My plan now is to wait until the week of August first and obtain samples and take them to Cardinal Labs in Hobbs, New Mexico and evaluate the results. We will copy you at this email with the lab results.
