BLM DENIES the work proposal as written. This site is with HIGH CAVE/KARST. A complete delineation will need to be performed, with an alternative proposal submitted for consideration. Additionally, both of these locations will need to have the berms repaired/replaced around each location due to being located in high cave/karst.

Also, you need to contact an archaeologist immediately and have the release area in the pasture surveyed. This release and excavation work in the pasture (that I do not see a request for approval) has potentially impacted an archaeological site.
