Your Characterization Plan for the location mentioned above which includes delineation plans that represent the previous release that has a case number of 2RP-4354 is approved with the following expectations:

- If it is EOG's intent to collect a background sample then taking said sample at the location that is marked on the site map, that EOG provided in this plan, is not accepted. Please make sure to take a background sample off pad in an area that appears to be in every way unimpacted by oil and gas activities. Please demark the new location that EOG selects on the site map that is provided during the work plan proposal phase.
- Chlorides will be delineated both vertically and horizontally to 600ppm chlorides in 1' intervals of lab tested samples.
- Your depth to water analysis consulted more than just one resource and OCD appreciates that. Although, two of the closest
  wells OCD found upon conducting their own depth to water analysis were USGS 323841104303201 that has a documented
  depth to water of 117.5ft bgs, and OSE well RA-6418 had a documented depth to water of 72ft bgs, however, when OCD
  factored in elevation etc. OCD saw that it is still feasible to go with a site ranking of 0 for the location of the release.

Please notify OCD when delineation activities are scheduled. Since federal minerals exist at this site like approval from the BLM may be required.
