In the document, at least twice, it is referred to as a "Closure Report". OCD DENIES, and is not reviewing the document as a Closure Report.

Part 4.0, third paragraph states "All contaminated soils will be removed and replaced with clean backfill....." OCD would approve the removal of <u>all</u> contaminated soils, if that is actually the proposal.

Table 3 lists "Sample Number on Figure 2" as L4. Figure 2 only shows one sample point labeled L1.

OCD does approve and does request additional delineation to adequately define impact. Once that is completed, OCD will consider a remediation proposal based on the delineation results.
