As written this work plan is denied.

OCD requires a full and proper delineation at every sampling point, this has not be achieved. Also OCD requires that sample points be representative of the spill plume area (please see COA document for guidance on this matter, sent to Bridger by OCD on 10/16/17). If location of production equipment is an issue then a new work plan proposal may need to include proposing the removal of infrastructure in order to achieve a proper delineation. Any and all contamination discovered at a site location is the responsibility of the current existing operator/lease holder. Based on site ranking, proximity to the river and potential for encountering shallow ground water, along with what has been identified so far as the TPH vertical plume OCD looks forward to seeing another work plan submission that properly addresses cleaning up this location.
