Camille.

Pursuant to our conversation, due to the fact this release was in sensitive cave/karst area, we request that you do not use extreme measures such as a hammer hoe to remove the impacted material. Due to the formation structure, we do not want any additional cracks and crevices. Please remove all impacted material to the best of your ability, using hand tools where necessary to dig around and between the bedrock cracks and rocks. We are not going to hold you to a TPH standard, but every effort will need to be made to remove the impacted material. Prior to backfilling, samples will need to be pulled and microblaze applied. All of the impacted area will need to be mircoblazed with special attention focused around the cracks and crevices. Follow-up samples will need to be pulled with additional microblaze treatments applied if necessary.

In regards to the nesting roadrunner, you will need to avoid disturbing her and her clutch of eggs. Need to keep a minimum of a 15' perimeter around her nest. Once the clutch has hatched, we can treat the area directly around her with microblaze.
