Again my apologies for the delayed response. I've attached the sampling analysis and diagram that we have prepared so far. As described in the C141, Lucid scrapped and disposed of the top layer of contaminated material as soon as possible after the release. These sampling results indicate the need for further excavation, which is what we have planned for. We are using a site ranking of 20 for this site, and the corresponding Recommended Remediation Action Levels, to guide the work. Unless you have any objections, Lucid will proceed with conducting the final necessary excavation work and collect closure samples. We'll then submit all of the collected information in a backfill/closure request for the site.

Mike and Crystal,

Please find the attached initial C141 for a release at the Roadrunner Gas Plant. On 3-4-18 a release of approximately 1000 gallons of Triethylene Glycol (TEG) occurred at the plant. At that time the plant was in startup/commissioning mode. The TEG had just begun to circulate and treat gas, so there is the potential for minor hydrocarbon contamination.

Remediation work has already begun by removing the more heavily contaminated gravel and pad material. Soil sampling will dictate what further actions are needed. We will prepare a remediation workplan and/or closure report, depending on the sampling results.
