On the Initial C-141 Marathon submitted for this release the volume was 27.62bbls. The volume that requires immediate notification to OCD is 25bbls or more. It is marked on the form that "no" immediate notice was given yet it then names Mike Bratcher and Shelly Tucker as being contacted to report immediate notice to however immediate notice is required to be given to OCD within 24hrs of discovery of release and there is a 72 hour gap in the times on the C-141 form between the date the release was discovered and the date and time in the immediate notice box. Previously, I had sent an excerpt from our regulations and even highlighted all of the things I am mentioning within that excerpt that I sent to multiple members of Marathon Oil Company.

I will not be going thru all of that again.

So I will make this clear if there is any confusion on our reporting requirements please refer to OCD Online and read our regulations for Release Notification 19.15.29 NMAC.
