Attached are two C-148 reports with water throughput volumes for the RDX Section 16 aboveground storage tank (2RF-117). As explained in the approved C-147 permit, this tank is used to store produced water prior to treatment for solids, hydrocarbons and bacteria. Treated water is then transferred to the existing RDX Section 16 facility (2FR-109). Therefore, the throughput volumes for this tank and the recycling facility are the same.
