The fluid was returned to the production tanks. The lined containment was power washed. A 48-hour advance notice was sent by email and the cleaned liner was inspected.

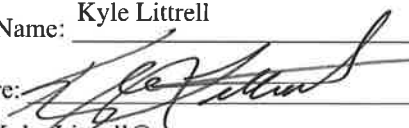

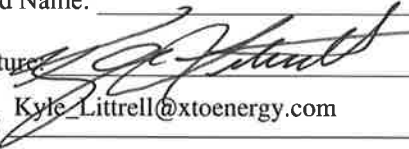

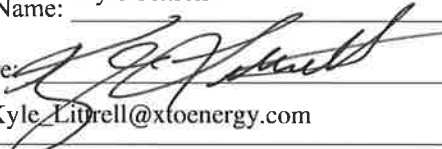
