OCD has received the C-141 Remediation Plan for 2RP-4694, thank you! At this time OCD cannot approve this Remediation Plan. This area is in high karst, therefore the remediation should be to Table 1 DTW < 50'. The contaminant targets are: Chlorides < 600 mg/kg, TPH < 100 mg/kg, BTEX < 50 mg/kg and Benzene < 10 mg.kg. It also looks like there is further delineation required on most of the sample sites. Finally, once the plan has been updated a C-141 Page 5 should be submitted with proposal. Please let me know if you have any questions.
