You are cleared for remedial activities off pad.

1. The release **did not impact any known archaeological area.**
2. The release impacted areas on and off location, but covered under a previous survey, **no additional surveys will be required.**
3. This area is located within a **Low cave/karst zone.**
4. This site is **cleared** of flood zones active playas, and intermittent streams, etc. **There is a dirt stock tank with a windmill <500' from edge of location.**
5. Area is noted to be within **0-3% slope.**
6. Soils within the area of release: **Berino complex and Kermit-Berino fine sands**
7. **BLM Seed Mix #2**, will be required.
8. The site is **NOT** located within **LPC, SDL and/or Shinnery habitat.** No other T&E species noted (animal or vegetative) within this area.
9. Site **IS** located within **Secretary of Potash Area** (no special remedial stipulations)
10. Site is **NOT** located within a **Special Area of concern.**
11. Site is **NOT** located within a **RMP ACEC.**
12. Site is **NOT** located within a **CRA Special Status Plant Species area.**
