We have received your Workplan/Remediation Proposal for <u>2RP-5103</u> Cal B Pipeline, thank you. This Workplan/Remediation proposal is approved.

The current NM OCD Environmental map does not consider this a "High Karst" area. Please excavate V-2 6", V-3 6", V-4 1' as explained in the proposed remediation plan, since they are relatively shallow. A best case effort needs to be made at V-1 4' either through a track hoe, hydro vac equipment, or other options to replace the 4 feet of contaminated soil with clean material. If resilient rock is encountered, please document the locations and depths, so we can have a full understanding of the situation.
