We understand the regulatory requirements for the site. Majority of the release has been remediated below the proposed concentrations, with the exception a small area along the very active lease road with high traffic. However, we also assumed there would be some flexibility in the rule and the chloride concentrations detected on the edge of the lease road do not appear to an environmental concern.

As stated in the submitted report, the areas of North Sidewall #5 and North Sidewall #6 could not be safely excavated or removed due to the location along a high traffic lease road. Based on the safety concerns, COG proposes to defer the areas of North Sidewall #5 and North Sidewall #6. Please let me know if you have any questions or concerns.

OCD has received your closure request for COG Screech Owl Fed #4H (<u>2RP-4944</u>) 8.18.18, thank you. Unfortunately, at this time, this closure request is not approved for the following reason:

- The release is located in a high karst area. OCD considers high karst area as "an unstable area". Please note that according to OCD rule, if a release occurs within an unstable area, the responsible party must treat the release as if it occurs less than 50 feet to groundwater in Table I of 19.15.29.12 NMAC.
- Analytical data for two sample points, North Sidewall# 5 and North Sidewall# 6, show chloride concentration values above the limit of 600 mg/kg. Based on these results, OCD considers that the contaminated soil at these two points is still in place and this closure cannot be approved.
