Rebecca,

We have received your Workplan/Remediation Proposal for **2RP-4969 State 647-711**, thank you. This Workplan/Remediation proposal is conditionally approved with the following conditions:

1. All off pad areas to contain a minimum of 4 feet non-waste containing uncontaminated, earthen material with chloride concentrations less than 600 mg/kg. This may require additional sidewall samples and further delineation
2. Performing a grab sample plan of the remediation area, where each composite sample is not representative of more than 200 ft²
4. Laboratory analyses of final sampling and a description of all remedial activities taken
5. Provide a scaled site and sampling diagram, photographs of the remediation site prior to backfill
6. All other closure reporting need to follow requirements set forth in 19.15.29.12 NMAC
7. Restoration, reclamation and re-vegetation to 19.15.29.13 NMAC

Rebecca,

There are a couple of issues with the SA/RP on the State 647-711. There are not enough sample points on the Site Assessment. We'll need samples that include the road and the northern portion that is off the pad also. Additionally, the 2 sample points that you included start at 2 feet and the other at 3 feet. We don't have samples at the surface on either. I recommend sampling from the surface in 1 foot increments.

Also, we do not use the point system any longer, so you can omit that from your characterizations in the future.
