XTO is requesting an extension to the 90-day timeline for completed remediation and closure report submittal required in 19.15.29.12.B.(1) NMAC at the Remuda S 25H 123H (RP# 2RP-5277). The release occurred on December 13, 2018. XTO began site characterization sampling on December 28, 2018. Drilling activities on and around the site prevented additional work to be completed. Initial confirmation sampling data indicate additional soil sampling is necessary. XTO estimates final work and reporting can be completed within two weeks. The 90-day deadline from the release date is March 13, 2019. XTO requests an extension of this deadline until March 27, 2019.
