Robert, each hydrovac can put out 20 bbls of water and is able to pick up 12-15 yards of solids. From the manifest from R360 they don't give a breakout of the exact amount of solids vs liquids that were picked up, we can tell you they recovered approximately 30 bbls of waste fluids and 20 yards of solids.
