OCD has received the initial C-141 for Tomb Raider 1-12 Fed 718H, thanks. Unfortunately, we cannot process your C-141 because the system requires an OGRID number (oil and gas report ID) to issue an RP#. In the OCD database, the responsible party for Tomb Raider 1-12 Fed 718H API # 30-015-44811 is Devon Energy Production Company. To continue processing this release, Devon Energy Production Company must send a signed initial C-141 for this spill.
