ETC request NMOCD permission to defer remediation of impacted soil affected the NMOCD Closure Criteria in the areas characterized by soil samples SEF NSW, SEF SSW, SEF WSW, SC Floor @3', ESW In-Situ and EW Stain In-Situ. Due to the loading dock, production equipment and water lines, OCD approves this request. The Final Report C-141 will be accepted for record and marked accordingly. The release will remain open in OCD database files and reflect an open environmental issue. This is a State site and will require like approval from SLO.
