Mr. Bratcher,

Thanks for your quick reply on this. You are correct, these wells share the same battery. Please see the attached vicinity site map showing both wells. By way of explanation, there were (4) C-141s sent to the OCD so I included them all for completeness.

Incident 2RP-5342 occurred in the separator battery of the Lone Tree Draw 13 State Com 2H location. Two other non-reportable incidents also occurred in the same area and overlap each other. The site conditions at the time of our site assessment are as shown on the site plan submitted for our proposed work plan.

Incident 2RP-4561 occurred in the lined central tank battery (Lone Tree Draw 2H well pad) and was tied to the Lone Tree Draw 13 State Com 8H well. Our intent would be to close both these incidents during our remediation activities.
