Ms. Venegas,

Under the new spill rule a closure report is due for the above release on 5/10/19. COG has submitted a work plan which was approved by the NMOCD on March 28, 2019, however COG is still awaiting approval from the State Land Office. We can't start remediation activities without State Land Office approval. COG is requesting a three month extension until August 9, 2019 in order to hopefully obtain State Land Office approval and conduct remediation activities and prepare a closure report. If we do not obtain State Land Office approval we may have to request an additional extension. Please let me know if you have any questions.

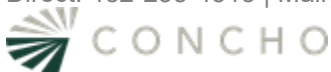
