Good afternoon,

Prior to opening up to flowback wells on an adjacent pad, a leak was discovered at the above ground storage tank (AST) at approximately 4:00 am. Upon investigation, a tear was discovered in the liner on the AST east side wall, causing produced fluid to be released onto the engineered pad. An earthen berm was built to contain the flow of fluid and vac trucks were used to remove the free standing liquids on location. The source of the leak has been stopped. Approximately 626 barrels of produced water was released with 400 barrels recovered. A crew was immediately dispatched to perform a scrape on location to recover saturated soil. A C141 will be submitted shortly.
