Mr. Brunson,

We have received your Workplan/Remediation Proposal for OXY - Sand Dunes 34 Federal #2 CTB (**2RP-5241**), thank you. This Workplan/Remediation proposal is approved with the following conditions of approval:

-  OCD will require all off road areas to be excavated to achieve the remedial criteria of 600 mg/kg for chloride.
-  All off road areas must contain a minimum of 4 feet of non-waste containing uncontaminated, earthen material with chloride concentrations less than 600 mg/kg.
-  Restoration, reclamation and re-vegetation to 19.15.29.13.NMAC.
