I think there is some confusion. This is the submittal that we have corresponded over several times about. It is not a Closure Report it was a Remediation Plan. We have had a couple of denials of our remediation plan each asking for additional information. I went through them and spoke with you several times to make sure that I was supplying what was requested. The last denial wanted a copy of the lab reports, along with some other information that was obtained. That made the file too large to attach so I mailed it, and inserted a copy of the online receipt with it. * That is why there is no signed copy of the C141 Closure Report. *The remedial plan identifies the process we are using to remediate clearly and asks for a variance in time to complete as we had discussed. * There also was a Analytical table behind the remediation plan and before the lab reports.

I was contacted by Ramona Marcus about the payment without a file for it and I was worried that this process was going to lead to confusion. She indicated that she would scan it in once she received it. The on-line process really isn't my favorite it should be set up where it was clear what it was you are actually submitting for approval, and it should be set up to handle larger files if it's information that is going to be requested.

- We would greatly appreciate if you include a table in the report that contains the lab result for each sample. Although not required by the rule, a summary table makes the report easier to read and understand.
