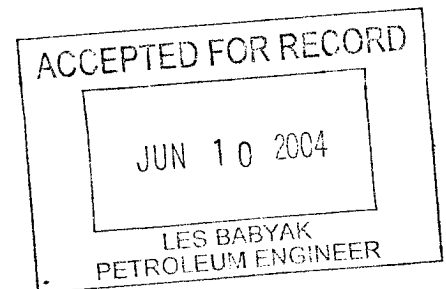

Tailed w/ 200 sxs Class C + additives. Bumped plug @ 0030 hrs with 925 psi. Circ 125 sxs cmt to pits. WOC. Cut off conductor and 9-5/8 csg, weld on wellhead and test. NU BOPE and test (notified BLM and instructed to proceed without witness).
