Ran 173 jts of 5 1/2", 17#, J-55 & 15.5#, J-55, LT&C casing set @ 7520'. Cemented with 750 sx Zone Seal foam cement. TOC by Temp Survey 3025'. Rig Released @ 11:55 pm on 5/24/04. Prep for completion.
