Yates Petroleum Corporation plans to plug and abandon this well as follows:

1. Rig up all safety equipment needed.
2. TIH with tubing open ended to +/-4150', circulate hole with 9.5# mud.
3. PUH to +/-3890' and pump 25 sx Class "C" cement for 100' plug inside 5-1/2" casing. TAG
4. PUH to +/-1485' laying down +/-2405' 2-7/8" tubing and pump 25 sx cement with additives for 100' plug in 5-1/2" casing. Tag plug.
5. Perforate casing at 426' and test casing to 500 psi. If holds, spot 100' plug inside 5-1/2" casing. If test does not hold, spot 100' plug adding 2% CaCl2 to cement. Tag plug.
6. Perforate casing at 60' and test casing to 500 psi. If holds, spot 60' plug inside 5-1/2" casing. If test does not hold, circulate 60' plug to surface. Tag plug.
7. Cut off wellhead and install marker.

NOTE: Yates Petroleum Corporation will use steel pits and no earth pits

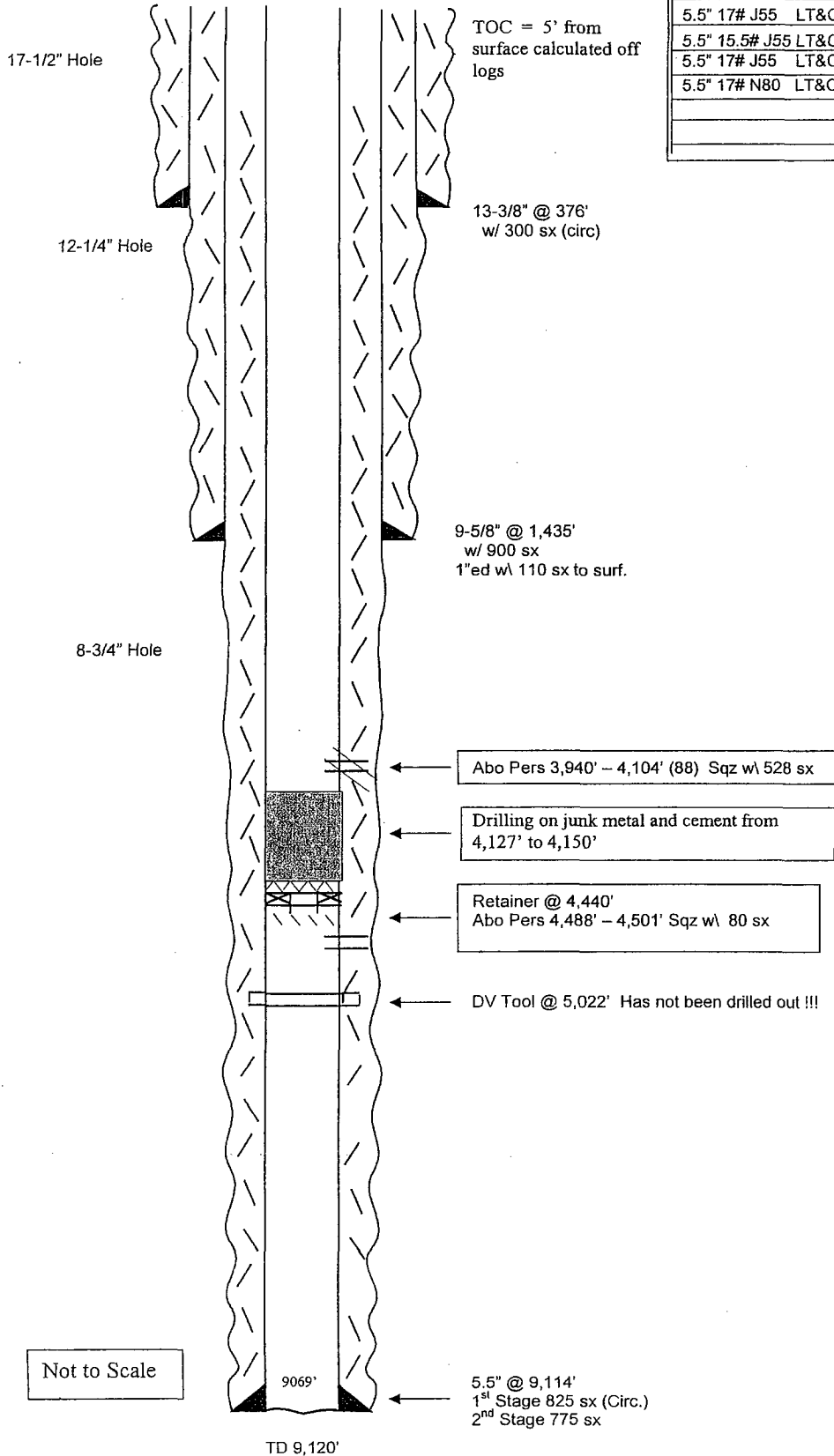
