5. Pick up PKR G.I.H. Set @ 2750' test to 500#'s for 15 mins. ok.
6. C.O.H. lay PKR dwn, pick up Production string G.I.H. w/94 jts. 2 3/8 tubing.
7. Run rods and pump.
