

**Instructions for  
Preparation for MIT  
Tests**

If your notification letter indicates “MIT Witnessed – Bradenhead” under the title “*Type Insp/MIT*” then the following applies:

**Bradenhead test** – Requires that injection pump be running and a operable pressure gauge or vacuum gauge installed on the tubing so that injection pressure may be witnessed. Does not require a pump truck. Casing & Bradenhead valves must be shut-in 24 hours prior to test. **PLEASE MAKE SURE YOU HAVE ENOUGH WATER TO RUN INJECTION PUMP ON DAY OF TEST.**

If your notification letter indicates “MIT Witnessed – Pressure test” under the title “*Type Insp/MIT*” then the following applies:

**Pressure Test** – Requires, in addition to the above, a pump truck capable of holding 300 psi on the casing for a period of 30 minutes. In addition a chart recorder is required with a 1000 psi capability and must have been calibrated within 12 months. Documentation of this calibration must accompany the recorder.

**A company representative must be on location during the test to operate valves and equipment. Ensure company representative has seen a copy of these instructions.**
