AFTER REVIEWING YOUR PROPOSAL OF 11/20/03 AND A SITE INSPECTION ON 8/12/04. THE FOLLOWING REQUIREMENTS ARE TO BE MADE BY THE ABATEMENT DATE OF 10/12/04. THE STOCKPILED, CONTAMINATED MATERIAL IS TO BE REMOVED FROM FEDERAL LANDS AND DISPOSED OF PROPERLY. CLEAN MATERIAL IS TO BE USED TO FILL TRENCH AT THE OLD BATTERY LOCATION. NOTE THIS MATERIAL CAN COME FROM THE AREA ADJACENT AND TO THE EAST OF THE DISPOSAL PIT. A FIREWALL, WHICH WILL HOLD 150% OF THE TOTAL TANKAGE IS TO BE CONSTRUCTED WITH FRESH CALICHI. A LOCATION FIREWALL IS TO BE CONSTRUCTED JUST OFF THE EDGE OF THE LOCATION TO PREVENT ANY FUTURE SPILLS FROM RUNNING OFF LOCATION. THIS IS TO EXTEND FROM THE TANKAGE FIREWALL TO THE NORTH, ALONG THE NORTHERN EDGE OF THE PAD. THEN FROM THE NORTH TO RUN SOUTH ALONG THE WESTERN EDGE TYING IN WITH THE ROAD. THIS MATERIAL WILL BE CLEAN CALICHI. REMOVE OUT OF SERVICE (Remarks continued on following page(s).)

The Authorized Officer has authority to issue a Written Order in accordance with 43 CFR 3161.2. Written Order correction and reporting time frames begin upon receipt of this Notice or 7 business days after the date it is mailed, whichever is earlier. Each stipulation must be corrected within the prescribed time from receipt of this Notice and reported to the Bureau of Land Management Office at the address shown above. If you do not comply as noted above under "Corrective Action to be Completed By", you shall be issued an Incident of Noncompliance (INC) in accordance with 43 CFR 3163.1(a). Failure to comply with the INC may result in assessments as outlined in 43 CFR 3163.1 and may also incur civil penalties (43 CFR 3163.2). All self-certified corrections must be postmarked no later than the next business day after the prescribed time frame for correction.

Section 109(d)(1) of the Federal Oil and Gas Royalty Management Act of 1982, as implemented by the applicable provisions of the operating regulations at Title 43 CFR 3163.2(f)(1), provides that any person who "knowingly or willfully" prepares, maintains, or submits false, inaccurate, or misleading reports, notices, affidavits, records, data, or other written information required by this part shall be liable for a civil penalty of up to \$25,000 per violation for each day such violation continues, not to exceed a maximum of 20 days.

Review and Appeal Rights

A person contesting a decision shall request a State Director review of the Written Order. This request must be filed within 20 working days of receipt of the Notice with the appropriate State Director (see 43 CFR 3165.3). The State Director review decision may be appealed to the Interior Board of Land Appeals, 801 North Quincy Street, Suite 300, Arlington, VA 22203 (see 43 CFR 3165.4). TANK AND HEATER TREATER. REMOVE SPILLAGE FROM OLD TANK. INSTALL A CATCH BASIN AT THE OIL LOAD LINE TO CATCH SPILLS. THIS BASIN IS TO HAVE A SCREEN OR GRATING TO KEEP BIRDS AND WILDLIFE OUT. REPAIR FENCING AROUND DISPOSAL PIT TO KEEP WILDLIFE OUT. IN ADDITION CEASE THE PRACTICE OF DRAINING BOTTOMS OFF TANKAGE.
