10/27/04 – Spudded 26" hole at 4:45 PM. Set 40' of 20" conductor and cemented to surface.

10/29/04 – Resumed drilling at 11:30 PM.

10/30/04 – Set 11-3/4" 42# H-40 ST&C 8rd casing at 909'. Cemented with 200 sx RFC (yld 1.6, wt 14.2) and 700 sx 35:65:6 (P/C) + additives (yld 2.1, wt 12.6). Tailed in with 200 sx Class "C" + 2% CaCl₂ (yld 1.32, wt 14.8). Cement circulated to surface. WOC 19 hrs. Tested casing to 600 psi for 30 mins. Reduced hole to 7-7/8" and resumed drilling.
