12/10/04 – Set 11-3/4" 40# H-40 casing at 906'. Cemented with 450 sx 35:65:6 "C" + 5% D44 + 3% S1 + .25 PPS D29 + 5#/sx D24 + .2% D46 (yld 2.1, wt 12.6). Tailed in with 200 sx "C" + 2% CaCl2 (yld 1.32, wt 14.8). WOC. Cement circulated to surface. WOC 18 hrs 30 min. Tested casing to 1000 psi for 30 min. Reduced hole to 11" and resumed drilling.
