Tailed in with 100 sx "H" + 8% A-10 + 5# LCM-1 + 1/4# Celloflake (yld 1.48, wt 14.6). Cemented stage 2 with 920 sx (35:65:6) "C" + 1/4# Celloflake + 5# LCM-1 + .3% FL-52 (yld 1.95, wt 12.5). Tailed in with 100 sx "C" + 3/10% FL-25 (yld 1.33, wt 14.8). Circulated 63 sx to pit on 2nd stage. Landed 7" casing 15' deep.
