
- 1) Set permitted 50 bbl fiberglass tank in ground to contain discharge from leak at wellhead.
- 2) MI&RU pulling unit. Replace section of casing @ surface where hole is located.
- 3) Haul all fluids from fiberglass tank to disposal.
- 4) Notify NMOCD & BLM Reps to begin sampling of prior emergency pit location and affected pad areas. All samples to be taken to Cardinal Labs in Hobbs to determine contamination depth.
- 5) Remove all contaminated soil and take to land farm.
- 6) Replace with clean soil.
- 7) Return well to production.
