2. RIH w/ tbg & 7" CIBP set at 7,593'.
3. Circulate hole w/ corrosion inhibited fluid.
4. Shut BOP & test casing to 500 psi for 30 min (10% leak off allowed). Chart test & report.
5. TOH laying down tbg.
6. Call BLM (505-234-5972) 24 hrs prior to conducting MIT. Chart test & report.
7. Clean up location and release equipment.

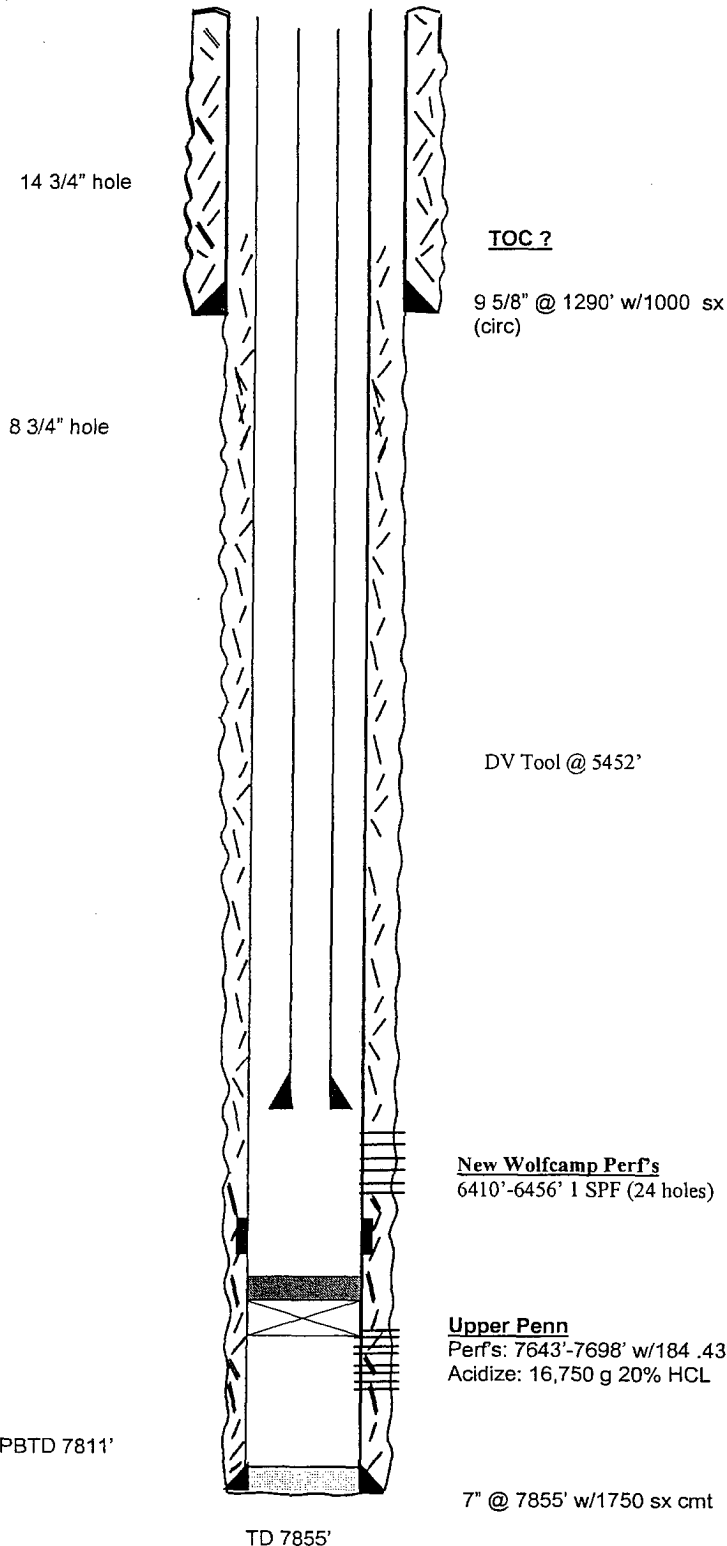

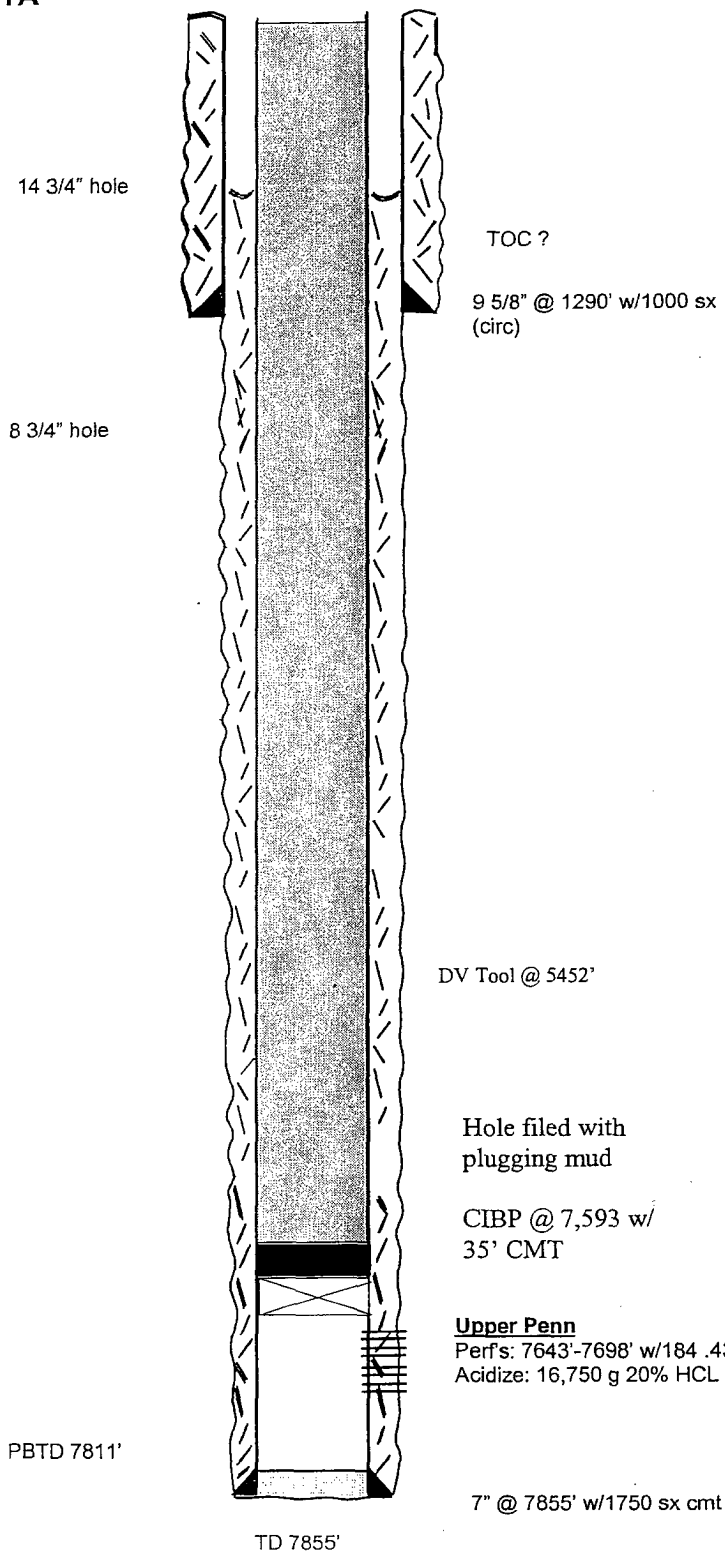
