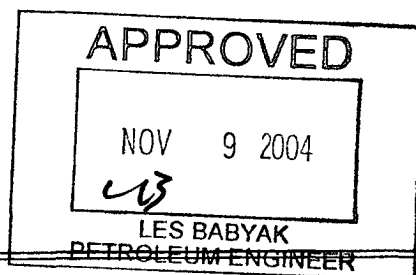

Due to the common royalty, overriding royalty and working interest owners in each zone and the anticipated reservoir pressures and production rates, we will downhole commingle the two zones upon completion and testing. Each zone will be isolated and tested sufficiently to establish allocation percentages before commingling.
